Biography

William W. Vance (1824 – 1909)

William was born December 21, 1824 in South Middleton Township, Cumberland County, Pennsylvania, the son of Daniel Vance and Margaret Glenn. Daniel Vance died young and William had to find work to support himself. At age 14 years William petitioned the Orphan's Court to appoint a guardian as his step-father was squandering his wages, William's only means for clothing and maintenance. His verified work experience was in the lumber business, as a laborer, clerk and eventually co-owner of Vance & Co., Ltd. Carlisle.

As a young man, William went to Montgomery County, Kentucky and eventually met his first wife, Eliza Jane Ingram. They had a daughter, Mary Elizabeth Vance. Eliza Jane refused to return to Pennsylvania and the marriage ended up in divorce. All records of the marriage and divorce were ruined during the Civil War when the Montgomery County Courthouse was destroyed. Mary Vance died at the age of 42 years from tuberculosis.

Returning to Carlisle, William again worked for a lumber company. On August 6, 1862, he left his job and volunteered for a nine-month enlistment with the 130th Regiment, Co. A, Pennsylvania Volunteers. He reported to Camp Curtin, Harrisburg and quickly attained the rank of sergeant. Within a month of reporting to Camp Curtin, he was participating in the Battle of Antietam at Bloody Lane.

After completing his military service, William married Harriet Fickel (1829 – 26 May 1888) of Adams County, PA. She died in 1888 without children and is buried in the Old Carlisle Graveyard.

In October of 1889 William married Amanda Fickel, (23 Nov 1854 -), niece of Harriet, and had seven children after he was 64 years of age. Amanda was born in December 1864 and was 30 years younger than William. She was the daughter of John W. Fickel (1820 – 1902) and Margaret Sellers (1821 – 1902) of Latimore Township, Adams County, PA. Children of William and Amanda were Willie, Margaret (born Nov. 1890), John (born Jan 1892), Mary E., Daniel H. (born Jan 1895), Robert G. (born Oct 1897) and Miriam. Three of the children died in infancy.

William was a member of the German Reformed Church, a charter member of the Captain Colwell Grand Army of the Republic (GAR) Post 201, the Odd Fellows Lodge and several other community organizations when he died October 22, 1909. He is buried in the historic Old Graveyard in Carlisle, Cumberland County, Pennsylvania.

Mary Elizabeth Vance (1854 – Sep 1892), daughter of William and Eliza Vance, married Thomas Cockram, year and specific location unknown. She died in Montgomery County, Kentucky.

Margaret Louise Vance (1890 – 1 Feb 1980) was born in Carlisle. She married Penn Lloyd Stambaugh (1883 – 1935) of Mechanicsburg during 1916. They had two daughters, Helen (1917 – 2007) and Charlotte (1927).

Margaret died in Harrisburg, Dauphin County, PA and is buried in the Mechanicsburg Cemetery.

John Wilbur Vance (1892 – Oct 1972) married Catherine Adams of South Carolina after World War I. He died in Jacksonville, Florida. John had one son, John W. Vance Jr.

Daniel Hastings Vance (6 Jan 1895 – Sep 1959) married Anna Turner who died during the flu epidemic after World War I. He later married Mary Hubbel of Windsor, Ontario. Daniel had children Wallace and Robert Bruce. He died in Cleveland, Ohio.

Robert Glenn Vance (6 Oct 1897 – Feb 1972) married Martha E. Myers of Carlisle on December 24, 1924. They had a daughter Betty. Robert died in Carlisle.

He is currently a life member of that historical society and a member of the Perry Historians. He is also a member of the Mifflin County Historical Society, the Lebanon County Historical Society, the Sons of Union Civil War Veterans, the Sons of Spanish-American War Veterans, the Palmyra Area Genealogical Society, the Connecticut Genealogical Society and the Pennsylvania Genealogical Society. In addition, Jim volunteers at the Lebanon County Historical Society as a genealogy research volunteer.
